

# FEES DUE NOTICE

## For Fall Sem. 2020

### FOR BSc NURSING STUDENTS

This is to remind all the students that the fees for **Fall Semester 2020** are due and payable with effect from **17<sup>th</sup> Aug. to 24<sup>th</sup> Aug. 2020.**

- ▶ **Adjustment of Refunds for unused portion of Spring Sem. Residence Hall Fees for Eligible Boarders:** The Boarder Fees, which includes fixed and other costs of providing Residence Hall and Dining services, will be refunded on a pro-rata basis and adjusted towards the Fall Semester Fees for continuing students. Based on the closure of the hostels on 27<sup>th</sup> March 2020, and factoring the official Start and Closing dates of the Spring Semester, the pro-rata refundable portion translates to **37% for Sem-V** and **41% for Sem-III** respectively of the Room and Food charges. This amount will be credited towards the Fall Sem 2020 Fees for returning Boarders.

Please note that for those students with any pending dues (such as outstanding module repeat fees, etc.), the refund adjustment will first be applied to settle outstanding dues and any remaining portion if any shall be credited towards Fall Sem dues.

- ▶ **Penalty for delayed payments:** Please ensure timely payments to avoid penalties for delayed payments.
- ▶ As per the COVID-19 advisories, the College will be reducing face-to-face transactions and cash handling, and all fees should henceforth be deposited by mobile payment / bank transfer only. Cash will be accepted only under exceptional circumstances.
- ▶ The payment modes/options and Fee Charts for the respective Semesters' are given below.
